Chromebook Expectations

Student Expectations

Understanding that having a district-provided Chromebook is a privilege and a tool to support my success in school, I agree to the following:

1. I will only use my district-provided Chromebook for educational purposes as directed by staff.
2. I will treat my Chromebook with care and protect it from damage and theft.
3. I will only use the district provided charger and bring my Chromebook to school fully charged each day. The school is not responsible for charging my Chromebook.
4. If the Chromebook was issued with a cover, I will keep the cover on the Chromebook to protect it.
5. I will immediately report any damage or loss to my school.
6. I will not alter my Chromebook (removable decoration is ok) and will return it in good condition.

Should the Chromebook signed out to me be misused or damaged by me OR anyone else, whether at school or outside of school, I understand and agree that I am responsible to pay for damage or replacement. Misuse of the Chromebook can result in it being taken back and/or consequences based on the Code of Conduct.

Parent/Guardian Expectations

As the parent or legal guardian of the above student, I agree that my child or ward shall comply with the terms above. I understand that the borrowing and use of a district Chromebook is a privilege and can be revoked if misused. I agree that if the Chromebook and/or charger is damaged, lost, or stolen that my child or I will reimburse the district for the cost of the repair or replacement and will not receive a replacement until that cost is paid. I agree to indemnify and hold harmless the School, and the School District that provides a Chromebook to my child or ward, against all claims, damages, losses and costs, of whatever kind, that may result from my child's or ward's use of his or her Chromebook or violation of the foregoing Agreement. Further, I accept full responsibility for supervision of my child's or ward's use of his or her Chromebook if and when such access is not in the school setting. I hereby give permission for my child or ward to use a Chromebook authorized by the School District and agree to the terms of this Agreement.

Damage Repair Costs

***These are estimates that can increase based on market price of parts.**

- Screen - Up to \$100 depending on the device model
- Keyboard/Touchpad - Up to \$65 depending on the device model
- Power Cord - Up to \$35 depending on the device model.
- Camera - Up to \$35 depending on the device model.
- Broken Case - Up to \$150 depending on the device model
- Full replacement (Lost/Stolen) - Up to \$350 depreciation value from Asset system

NOTE: Each student is responsible for the Chromebook they signed out at all times. This includes situations in which another student is suspected of causing damage or loss to that Chromebook. Schools will investigate and pursue disciplinary action per the Code of Conduct should this occur in school.
